Anarchist Prophets James R. Martel 2022-08-05 In *Anarchist Prophets* James R. Martel juxtaposes anarchism with what he calls archism in order to theorize the potential for a radical democratic politics. He shows how archism—a centralized and hierarchical political form that is a secularization of ancient Greek and Hebrew prophetic traditions—dominates contemporary politics through a prophet's promises of peace and prosperity or the threat of violence. Archism is met by anarchism, in which a community shares a collective form of judgment and vision. Martel focuses on the figure of the anarchist prophet, who leads efforts to regain the authority for the community that archism has stolen. The goal of anarchist prophets is to render themselves obsolete and to cede power back to the collective so as to not become archist themselves. Martel locates anarchist prophets in a range of philosophical, literary, and historical examples, from Hobbes and Nietzsche to Mary Shelley and Octavia Butler to Kurdish resistance in Syria and the Spanish Revolution. In so doing, Martel highlights how anarchist forms of collective vision and action can provide the means to overthrow archist authority.

Shakespearean Readings Carlo Maria Bajetta 2014-09-03 This volume contains a series of papers we delivered at the annual Shakespeare conference held at the Università Cattolica di Milan over three years. During this period our research interests ran on more or less parallel lines, moving from Shakespeare's sonnets to the Bard's influence on Keats and Shelley. If this was probably due to a similar way of interpreting the conference titles, it was just a coincidence that both of us devoted particular attention to *King Lear*. This play, we discovered, was particularly relevant to the work we were autonomously carrying out, Luisa Camaiora being then engaged in writing her book on Keats's Odes, and Carlo Bajetta editing Shelley's *Peter Bell*. As a consequence, we started mentioning articles, discussed recent research, and there was much swapping of books - which created more than a little confusion in our bookshelves, and much irritation in some University librarians. When we looked back at these essays, we were surprised to note that a fil rouge seemed to run through them. From the ambiguities of one of Shakespeare's most famous sonnets, number 116, they move on to describe the allusive structure of the sonnet-chorus of *Romeo and Juliet*, hence to the complexities of the initial scene of *King Lear* and the uses to which this play was put by Keats and Shelley; they eventually come back to Keats's relationship with the works of the Bard, and finally to yet another sonnet, which constitutes in many ways an original re-reading of Shakespeare. 'Shakespearean Readings', alluding to both textual variants, critical analysis, and a writer's understanding of a literary work, seems to be a fitting title to describe this red thread. 'Passage' and 'Traffic' in *Romeo and Juliet* and 'Textual Madness: *King Lear*'s peregrinations' were first published in *To go or not to go? Catching the moving Shakespeare* (ed. L. Camaiora, Milan, I.S.U. Università Cattolica, 2004), 'John Keats and his Presider Shakespeare' and 'Shakespeare's Sonnet 12 and Keats's "When I have fears"' appeared in a different form in *L'Analisi Linguistica e Letteraria*, 7:1, 1999, while 'Shelley's Shakespearean Mockery of Wordsworth', which was read at the Shakespeare Days conference in April 2003, both relies on and integrates some sections of the introduction to *Peter Bell: the 1819 Texts* which appeared in December of the same year (Mursia, Milan). The "Sacred History" of Euhemerus of Messene Marek Winiarczyk 2013-04-30 In his utopian novel *Hiera Anagraphe* (Sacred History) Euhemerus of Messene (ca. 300 B.C.) describes his travel to the island Panchaia in the Indian Ocean where he discovered an inscribed stele in the temple of Zeus Triphylus. It turned out that the Olympian gods (Uranos, Kronos, Zeus) were deified kings. The travels of Zeus allowed to describe peoples and places all over the world. Winiarczyk investigates the sources of the theological views of Euhemerus. He proves that Euhemerus' religious views were rooted in old Greek tradition (the worship of heroes, gods as founders of their own cult, tombs of gods, euergetism, rationalistic interpretation of myths, the explanations of the origin of religion by the sophists, the ruler cult). The description of the Panchaia society is intended to suggest an archaic and closed culture, in which the stele recording *res gestae* of the deified kings might have been preserved. The translation of Ennius' *Euhemerus sive Sacra historia* (ca. 200 - ca. 194) is a free prose rendering, which Lactantius knew only indirectly. The book is concluded by a short history of Euhemerism in the pagan, Christian and Jewish literature.

In Search of Pythagoreanism Gabriele Cornelli 2013-04-30 The history of Pythagoreanism is littered with different and incompatible interpretations, to the point that Kahn (1974) suggested that, instead of another thesis on Pythagoreanism, it would be preferable to assess traditions with the aim of producing a good historiographical presentation.
